After spending three years as Research Chemist at Flamel Technologies company in Lyon, France working on biomedical polymers, in December 1994, he joined the Department of Chemistry at the University of Mauritius as Lecturer and was appointed Professor in 2005. He held the post of National Research Chair in Biomaterials and Drug Delivery under the Mauritius Research Council from 2012 to 2016. He founded and headed the Centre for Biomedical and Biomaterials Research (CBBR), a centre attached to the University of Mauritius, from 2011 to 2016.</p>	
	<p>Prof Jhurry worked on sucrose-based polymers for his PhD. His mainstream research in polymer science, biomaterials and tissue engineering, nanotechnology/nanomedicine and drug delivery has led to 70 papers in scholarly journals. He is a member of the Editorial Board of Polymer International and also a member of the IUPAC Committee on Polymers.</p>
